Mr. Dropkin recused himself from discussions and sat in the audience as he is currently a consultant to Amy's Kitchen, Inc.

Mr. Trelstad gave a brief description of the project and the new properties that are now a part

of the project and were discussed at the June PB meeting. He pointed out that the scoping document was amended to include the additional properties. He said that he had site plans available if anyone from the public would be interested in looking at them. There was no one present from the public.

It was stated that the Scoping Document for Amy's Kitchen, Inc. Draft Environmental Impact Statement was posted on the Town website on June 24, 2015 and was reviewed by the Town's consultants and the PB.

Ms. Naughton told the PB that she will include in the scoping document any agreed upon suggested changes to the scope made tonight. She said she has reviewed a memo from the Town Environmental Review Board relating to the scope and discussed incorporating some of its content.

The PB discussed the July 16, 2015 letter from the Orange County Department of Planning and its four advisory comments regarding traffic, water quality, quality of life and consistency with Goshen and County plans. Mr. Hoffman said that many of the County's comments were already included in the scope.

Many aspects of the scoping document were discussed by PB members and there were additions and modifications made to the document by the Town's consultants and PB members. Several PB members concluded that the scoping document was thorough and extensive.

Mr. Bergus asked for public comment. There was none.
