MINUTES

A Regular Meeting of the Town Board of the Town of Goshen, was held on the 14th day of August, 2014 at the Town Hall located at 41 Webster Avenue, Village of Goshen, County of Orange, State of New York.

A. CALL TO ORDER:

Supervisor Bloomfield called the meeting to order at 7:30 p.m., and led the Pledge of Allegiance.

- **B. AMENDMENT TO THE AGENDA:** Attorney Caplicki stated he would like to add authorization for either he or Supervisor Bloomfield to approve and sign a letter in reference to the Cable TV Franchise.
- C. PRIVILEGE OF THE FLOOR: No response
- D. PUBLIC HEARING: PROPOSED LOCAL LAW 3 OF 2014 "PROPERTY MAINTENANCE"
 REPLACING EXISTING CHAPTER AND ADDING NEW CHAPTER 75

Councilman Canterino made a Motion to open the Public Hearing, Seconded by Councilman Newbold. Motion carried unanimously.

Supervisor Bloomfield asked for input from the public. No comments from the public. Councilman Lyons question the Agricultural section of the law, which the Board discussed. Councilman Lyons also questioned the discrepancy of the dates on page three and four of the Law; page three stating 10 days, and Page 4 stating 7 days. Attorney Caplicki said that the number of days is seven (7) and he will correct the discrepancy.

Councilman Lyons moved to close the Public Hearing, Councilman Canterino seconded the Motion. Motion carried 5 to 0.

Councilman Lyons made a Motion to approve and adopt Local Law #3 "Property Maintenance", the Motion was seconded by Councilman Cappella.

Councilman Newbold said he would like to recognize Legislator Shannon Wong who is here tonight. The Board welcomed her.

E. OLD BUSINESS:

1. Amendment to the Agenda: Authorize the Supervisor to sign a letter re: waiver 894. Attorney Caplicki explained that to enable an area that Time Warner does not service, to be serviced by Cablevision, the Town has to request a waiver from the New York Public Service Commission, from part 894 of the Franchising Procedures.

Attorney Caplicki read the letter to the Board for approval. Councilman Lyons made a Motion to authorize the Supervisor to write a letter to the New York Service Commission requesting the waiver. The Motion was seconded by Councilman Newbold. Motion carried 5 to 0.

- 2. Discuss and approve Resolution to authorize the code enforcement officer to have 310 Maple Avenue property cleaned up: Attorney Caplicki explained that the Resolution is not ready, as the notices were not sent out early enough. After discussing the problem, it was decided to put this on hold until the next work session.
- 3. DISCUSS AND APPROVE TAX CERTIORARI SETTLEMENT WITH REALTY EQUITIES GOSHEN LLC AND AUTHORIZE THE SUPERVISOR, ATTORNEY FOR THE TOWN, AND ASSESSOR TO SIGN THE SAME: Attorney Caplicki reviewed the Tax Certiorari with the Board, and said that this parcel is the old mall where CVS is located. Councilman Newbold made the Motion to approve the Tax Certiorari Settlement, Councilman Lyons seconded the Motion, the Resolution is as follows:

JAMES SKOUFIS, NYS ASSEMBLYMAN REPRESENTING THE 99TH DISTRICT, HAS SECURED A \$1,000 GRANT TO ASSIST IN REFURBISHING THE GOSHEN SENIOR CENTER: Councilman Cappella explained that last year they painted the main hall, and refurbished the bathrooms, foyer, and the other rooms. He said there is a long list of different items that have to be done, and this money will be a big help. He thanked Assemblyman Skoufis for his help.
- **G. FINANCE:** Councilman Canterino made a Motion to authorize the Supervisor to pay Manual A/P runs as of 08/04/14 amounting to \$77,353.73 and Accounts Payable Check Run for 8/14/14 amounting to \$479,261.18. Councilman Lyons Seconded the Motion. Motion carried unanimously.
