A. CALL TO ORDER

The meeting was called to order by Supervisor Bloomfield at 7:34pm, followed by the Pledge of Allegiance.

- D. OLD BUSINESS:
 - REVIEW INTRODUCTORY LOCAL LAW NO.1 OF 2017 WHICH MODIFIES VARIOUS SECTIONS OF THE TOWN OF GOSHEN CODE TO OMIT TYPOGRAPHICAL ERRORS AND TO AMEND PROVISIONS TO ENSURE CONSISTENCY AND CLARITY.

Attorney Torre reviewed the first part of the above mentioned Local Law at our 10-10-17 Monday meeting. Dennis Lindsay, P.E. addressed the Board to review the second part pertaining to water protocols. He explained that the water testing protocols in our Town Code were appropriate with respect to community water supplies. However, with changes to subdivisions, below the threshold of 49 homes which do not require a community water supply, water testing protocols were written for a number of wells to be built and analyzed for sufficient water within the development. When the changes were published in our Code book, reference notes were published instead of the actual protocols. The changes in this Introductory Local Law *spell out* the water testing protocols for multiple lots with wells. Mr. Lindsay, P.E. reviewed minor changes within "B Protocols for Well Installation, Testing and Reporting – Community Water Supplies" which are updated.

SEQRA documents will be prepared by the engineers at H2M. Attorney Golden will prepare the Environmental Assessment Form for review/adoption. Then a public hearing will be set.
