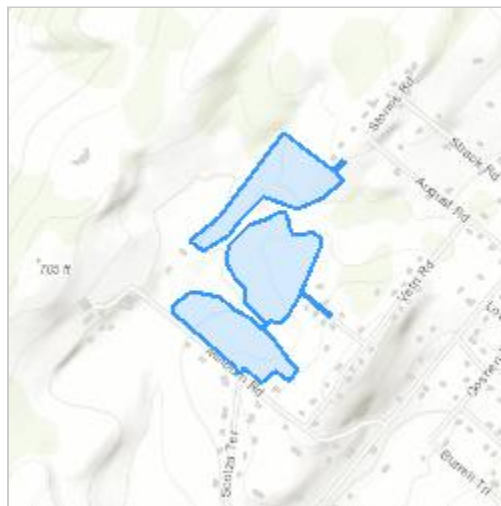

Project Description: Project Summary: The proposed project is a ground-mounted solar electric power generation facility (10.9 MW DC) in the Town of Goshen, Orange County. The proposed project will be developed inside two perimeter fences (shown in red on the attached map) for a combined ~38 acres on one tax parcel. Attendant features will include an electrical interconnect and three access roads as shown on the attached map. The parcel is approximately 58.90 acres in size and is used for agriculture as a hay field. The information is being requested for project planning to avoid and minimize environmental impacts as well as for planning board approval from the Town of Goshen. The current land use is agricultural hay field cropland with wooded areas adjacent to the open fields and potential wetland features.
